

Classification National Protest Form

An NPC/NF may only make a Protest in respect of an Athlete under its own jurisdiction at a Competition. The NF/NPC must show that the Protest is bona fide with supporting evidence and complete this Protest Form. The Protest Form must be submitted in accordance with Articles 16.4.022 and 16.4.023 of the UCI Cycling Regulations. If, in the discretion of the Chief Classifier, the Protest does not comply with the protest requirements laid out in Articles 16.4.022 and 16.4.023 of the Rules, the protest will be dismissed.
